### Minutes

**Approval of Minutes from the August 12, 2021 Meeting:** Sandy West made a motion to approve the minutes and was seconded by Diane Yeoman. All approved and motion passed.

## **SHARE Update:**

- **SHARE Mobile Library App:** The SHARE Mobile Library App had its soft launch yesterday, October 6<sup>th</sup>. The official launch is expected on October 25.
- **Windows 11 Update:** The Windows 11 rollout has begun, and Internet Explorer is being retired. This changes the way that most libraries access Polaris.
- Polaris 7.0 Upgrade: On Saturday, October 10, Polaris will upgrade to Polaris 7.0. Dena Porter will prepare a highlight reel of the new features. This upgrade will also feature updates to LEAP.
- collectionHQ: Jane Herb from Baker & Taylor gave a brief demonstration of their new collectionHQ DEI analysis tool, which helps filter, sort, and analyze a library's collection, based on industry-accepted DEI topics.

### **Old Business:**

• Free Non-Resident Cards: The committee discussed allowing non-residents e-resources cards, but the system of doing that would be difficult, and the interest in the program is low. No action will be taken on the issue unless there is further interest in the future.

- NetLibrary Books: NetLibrary e-books were added to the catalog by the Lincoln Trails Library
  System and grandfathered into SHARE. The e-book technology is outdated and may have lost
  functionality over time. The committee discussed beginning the process of removing these titles,
  given their age and non-functionality. Susan McKinney made a motion to recommend the removal
  of these items, seconded by Esther Curry. All approved and the motion passed. SHARE will
  distribute a notice of the removal of these records.
- Other: None.

#### **New Business:**

- **Aspen/Vega:** Cassandra Thompson asked for feedback regarding the new discovery layer demos. This committee has been tasked with choosing between the two products and making a recommendation. Cassandra Thompson will compile a comparison between the two and present it to the committee at the next meeting.
- McNaughton: The committee discussed the McNaughton book leasing program. This program
  would allow libraries to increase circulation of high-demand items by leasing books with an option
  to purchase. These books would be dropped into the hubs and sent to the leasing library through
  IHLS Delivery. This program would also help to reduce hold times overall. The committee
  expressed interest in looking further into the program before making a final decision.
