Following the election of officers, Scott Drone-Silvers conducted the meeting.

- New vendors—Lesley Zavediuk requested that committee members let her know if there are vendors they would like to obtain information or offers from.
- Vendor offers—Lesley Zavediuk reported on information she's received from Biblioboard and the Hot Spot lending program from Verizon. The consensus of the committee was that more information was needed—both from Verizon and libraries interested in participating—which should be presented at the next meeting.
- Cloud Library—2 new libraries have joined, making the total number of participating agencies 171, or 202 libraries. Since the eRead Illinois grant is complete, and that Advisory Committee is no longer in existence, this committee will need to complete an annual review of the loan rules, purchase practices, and fees.
- Zinio—four new libraries joined the consortium in December.
