Call meeting to order and roll call: The meeting was called to order at 3:11 pm by chair Scott Drone-Silvers.

Approval of Minutes of March 28, 2016 meeting: The minutes were approved on a motion made by Ryan Johnson, and seconded by Lauren Erwin. All ayes; no nays; motion passed.

Old Business:

- Cloud Library survey—Lesley Zavediuk—the consensus among members participating in the survey was that the loan rules should remain the same; at present, that means there is a limit of five checkouts, five holds, and 3 days to hold an item before it becomes available to the next patron; the consensus of this committee is to maintain the current circulation rules;
- eResources & the PAC—Michelle Ralston—web addresses for individual library's eResources can be featured on that library's portal page on the PAC, through the customization process; Michelle will develop a SHARE newsletter to remind members about the options with regard to customizing their portal pages;
- Federated Searching & Polaris—Troy is working on getting a list from Polaris that indicates which eResources can be linked to Polaris for federated searching; there would have to be some patron training to make the federated searching work; more information is needed before the option for libraries to use federated searching is presented to members.
